INVITATION TO BID

1. **Client: Serbian Health Insurance Fund**

The Serbian Health Insurance Fund is obliged to conduct the public procurement procedure for dialysis materials – dialysis machines for the period of one year, pursuant to Article 17a of the Ordinance of the Government of the Republic of Serbia on planning and types of goods and services subject to centralized public procurement ("Official Gazette of the Republic of Serbia", No. 029/2013, 049/2013, 51/2013-as amended and 86/2013), for the purposes of healthcare institutions with which the Serbian Health Insurance Fund has entered into agreement on provision of healthcare services.

The Serbian Health Insurance Fund as the Client shall conduct public procurement procedure and enter into framework agreements, while individual procurement contracts shall be entered into by healthcare institutions, based on framework agreements.

8. Criterion, criterion elements for contract award: economically most favourable bid

1. Evaluation and ranking of the most favourable bids shall be conducted by applying the following criterion elements:

1.1 Quoted unit price, exclusive of VAT - 50 points at most

1.2 Quality – 50 points at most

12. Method of bid submission and deadline for bid submission:

- Bidders shall submit their bids to the CA directly or by mail.
- Bidders shall file their bids in a closed envelope or a box so as to ensure that during the bid opening procedure it may be verified that an envelope or a box is opened for the first time.
- An envelope or a box containing a bid must be labelled as follows "BID FOR PUBLIC PROCUREMENT OF DIALYSIS MATERIALS-DIALYSIS MACHINE FOR THE PERIOD OF ONE YEAR, FOR LOTS _____, public procurement No. 404-1-110/14-66, - DO NOT OPEN".
- Bidders shall indicate their address, phone number and responsible persons at the back of an envelope or a box.
- Bids must be submitted directly to the address of the Serbian Health Insurance Fund, 2 Jovana Marinovića St., Belgrade– Office No. 13.
- The deadline for bid submission shall be 30 days as of the announcement of the invitation to bid at the Public Procurement Administration Portal, and/or by **09 June 2014, 12.00h.**
- Timely received bids shall be those received by the CA by term referred to in above paragraph, whatever the method for submission of bids has been used.

13. Place, time and method of bid opening:

- Bids will be opened **on 09 June 2014 at 12.30 h** in the premises of the Serbian Health Insurance Fund in Belgrade, 2 Jovana Marinovića St., Office No.2.
- Bids shall be opened in the order received/registered by the CA.

14. Requirements to be met by bidders' representatives for participation in bid opening procedure:

- Bidders' representatives who chose to attend the session of public bid opening shall present to the CA's Committee their authorizations for the participation at the session.
- Authorized representatives of bidders participating in bid opening sessions are entitled to make inspection on the data from a bid which will be recorded in the report on bid opening procedure and make remarks on bid opening procedure.

15. Deadline for adoption of the decision: within 25 days as of bid opening date
