INVITATION TO BID

- 1. Contracting Authority (CA): Serbian Health Insurance Fund

The Serbian Health Insurance Fund shall on behalf of and for the account of healthcare institutions conduct public procurement procedure and enter into framework agreement based on which the healthcare institutions shall enter into individual public procurement contracts

- 5. Type of Procedure: open procedure
- 6. Type of goods: goods
- 7. Description of scope of procurement, name and designation in Common Procurement Vocabulary (CPV):
 - The scope of public procurement includes medicines for the treatment of multiple sclerosis;
 - Name and Code under CPV: 33600000 Pharmaceutical Products.
 - 8. Number of lots: Public procurement shall be divided in 5 lots
 - 9. Framework Agreement Validity Term: 12 months
 - 10. Type of Framework Agreement: single supplier Framework Agreement
 - 11. Criterion, criterion elements for contract award: the lowest price

The criteria for evaluating bids is lowest price of annual treatment cost, that is obtained by using following formula:

Pshif * Pannual
Pshif * Cbid

Legend:

P_{shif} – Number of patients being treated at the expense of SHIF;

Pannual - Number of patients being treated at the expense of bidder;

C_{bid} – Treatment cost for patient for 52 weeks period

- 14. Method of bid submission and deadline for bid submission:
- · Bidders shall submit their bids to the CA directly or by mail
- Bidders shall file their bids in a closed envelope or a box so as to ensure that during the bid opening procedure it may be verified that an envelope or a box is opened for the first time.
- An envelope or a box containing a bid must be labelled as follows "BID FOR PUBLIC PROCUREMENT OF MEDICINES FOR THE TREATMENT OF MULTIPLE SCLEROSIS, FOR LOTS______, public procurement No. 404-1- 110/15-51, DO NOT OPEN ".
- Bidders shall indicate their address, phone number and responsible persons at the back of an envelope or a box.
- Bids must be submitted directly to the address of the Serbian Health Insurance Fund, 2 Jovana Marinovića St., Belgrade— Office No. 6, on working days, during working hours.
- Timely received bids shall be those received by the CA by 26 June 2015 by 10.00h, whatever the method for submission of bids has been used.
 - 15. Place, time and method of bid opening:
- Bids will be opened on 26 June 2015 at 11,00 h in the premises of the Serbian Health Insurance Fund in Belgrade, 2 Jovana Marinovića St., Office No. 3.
 - Bids shall be opened in the order received/registered by the CA.
 - 16. Requirements to be met by bidders' representatives for participation in bid opening procedure:
- Bidders' representatives who chose to attend the session of public bid opening shall present to the CA's Committee their authorizations for the participation at the session.
- Authorized representatives of bidders participating in bid opening sessions are entitled to make inspection on the data from a bid which will be recorded in the report on bid opening procedure and make remarks on bid opening procedure.
 - 17. Deadline for adoption of the decision: 25 days as of bid opening date
