INVITATION TO BID

1. Contracting Authorities (CAs): National Health Insurance Fund (NHIF) & Fund for Social Insurance of Military Insurees
2. CAs' Addresses: 2 Jovana Marinovića St., Belgrade & 13 Krunska St., Belgrade

4. Type of CAs: Organization for mandatory social insurance

NHIF & Fund for Social Insurance of Military Insurees have signed decision on joint conducting specific public procurement procedure on 12th of July 2019. As specified in previously mentioned decision, NHIF will conduct public procurement procedure, upon which Institute of Public Health of Serbia „Dr Milan Jovanovic Batut” and Fund for Social Insurance of Military Insurees shall enter into individual public procurement contracts.

5. Type of Procedure: open procedure

6. Type of goods: goods

7. Description of scope of procurement, name and designation in Common Procurement Vocabulary (CPV):

The scope of public procurement includes influenza vaccines for season 2019/2020; No 404-1-110/19-39.

Name and Code under CPV: 33651660 – Influenza vaccines, for all lots.

8. Number of lots: Public procurement shall be divided in 2 (two) lots

9. Criterion, criterion elements for contract award: the lowest price

10. Method of collection of tender documents: tender documents may be downloaded from the Public Procurement Administration Portal and the NHIFs web address www.javnenabavke.rfzo.rs.

11. Method of bid submission and deadline for bid submission:

- Bidders shall submit their bids to the NHIF directly or by mail.
 - Bidders shall file their bids in a closed envelope or a box so as to ensure that during the bid opening procedure it may be verified that an envelope or a box is opened for the first time.
- An envelope or a box containing a bid must be labelled as follows "BID FOR PUBLIC PROCUREMENT OF INFLUENZA VACCINES FOR SEASON 2019/2020, FOR LOTS , public procurement No. 404-1-110/19-39 - DO NOT OPEN".
 - Bidders shall indicate their corporate name, address, phone number, e-mail and responsible persons at the back of an envelope or a box.
 - Bids must be submitted directly to the address of the NHIF, 2 Jovana Marinovića St., Belgrade, Registry office, from 07,30 AM till 3,30 PM, Monday – Friday.
 - Timely received bids shall be those received by the NHIF by 8th of August 2019 by 10,00 AM, whatever the method for submission of bids has been used.

12. Place, time and method of bid opening:

- Bids will be opened on 8th of August 2019 at 11,00 AM in the premises of the NHIF in Belgrade, 2 Jovana Marinovića St., Office No. 3.

- Bids shall be opened in the order received/registered by the NHIF.

13. Requirements to be met by bidders' representatives for participation in bid opening procedure:

- Bidders' representatives who choose to attend the session of public bid opening shall present to the CAs' Committee their authorizations for the participation at the session.

- Authorized representatives of bidders participating in bid opening sessions are entitled to make inspection on the data from a bid which will be recorded in the report on bid opening procedure and make remarks on bid opening procedure.

14. Deadline for adoption of the decision: 25 days as of bid opening date, except in especially reasonable cases, when the deadline for adoption of the decision can be 40 days as of bid opening date.
